PRINCIPLE OF OPERATION

The patented technology of electromagnetic suppression of pathogens is based on scientific research of the scientists from Concern GRANIT JSC Research Center, as well as on the other Russian and foreign scientists' works in the field of electrodynamics, virology, and also on works by Academician N.D. Devyatkov, recognized as a pioneer of medical electronics.

Innovative method of coronavirus suppression is successfully implemented in TOR device. The principle of it's operation is based on a special electromagnetic impulse treatment suppressing SARS-CoV-2. TOR helps to slow down the virus replication process. That gives human body time to build up immune protection and reduces risk of the virus infection.



TOR device increases the efficiency of treatment of COVID-19 patients and reduces the period of patients' stay in medical institutions.






